Steve Gold is an attorney who specializes in civil rights and only represents persons with disabilities. He is known as the “Godfather” of the Olmstead Supreme Court Decision due to his legal theory under the ADA that unnecessary institutionalization is discrimination. Several years before Olmstead, he argued the case, Helen L., that a state discriminates against a person by requiring them to receive services in a segregated nursing home rather than providing services in the community. Come hear Steve Gold speak on the Olmstead Decision of 1999; Missouri courts and Olmstead; amount of money spent on institutionalization versus community living and the AARP Scorecard.
